On initial appointment, the following pay and allowances are admissible:

	<ul style="list-style-type: none"> Upper age limit is relaxable by 5 years for SC/ST and by 3 years for OBC candidates. Upper age limit is relaxable for departmental candidates' upto 40 years of age who have rendered 3 years of regular and continuous service. The age limit is relaxable up to age of 35 years for general candidates and up to 40 years for SC/ST in case of widows, divorced women and women judicially separated from their husbands and not remarried. The age limit is relaxable for ex-servicemen as well as for the children & dependents of victims of communal riots of 2002 in Gujarat & Sikh riots of 1984 as per the Govt. instructions in this regard issued by the Central Government from time to time. The age limit is relaxable up to maximum 5 years to the meritorious sportspersons specified in Para 1 (a) of DoP& AR O.M. No. 14/15/1/76-Estt.(D), dtd 4.8.1980. The candidate claiming age relaxation in this category must have the desired certificate in the form & from the authority prescribed in OM under reference.

Note 1: The post of ACIO-II/Exe, being an operational post, is not reserved for PwD. Hence, they NEED NOT apply.

Note 2: The reservation of vacancies for EWS, OBC, SC, ST, Ex-Servicemen is as per rules/roster.

Note 3: The number of vacancies is provisional and liable to change.

Note 4: The eligibility of the candidates in terms of age, educational qualification, caste/category, etc. will be determined on the closing date. The candidate must possess essential qualification for the post i.e. Graduation or equivalent on the closing date, i.e. 15.12.2023 (till 2359 hours).

Note 5: Successful completion of mandatory induction training of at least two weeks duration is a pre-requisite for completion of probation.

2. SERVICE LIABILITY: The post involves All India Service Liability. Therefore, the candidates willing to serve anywhere in India only need to apply.

3. CITY OF EXAMINATION: The candidates may refer to the detailed advertisement. Note 1: While filling in the online application form, the applicant should carefully decide about his/her choice of City of Examination.

Note 2: The candidate has to choose five (5) options/choices as Examination City from the list provided in the detailed advertisement.

Note 3: Examination City, once opted, will not be changed under any circumstances.

Note 4: In case of over subscription/under subscription at a particular City, the candidates may be shifted to some other City.

4. SCHEME OF EXAMINATION:

Note-1: Candidates appearing in interviews may be subject to Psychometric/Aptitude test which will be a part of interview.

Note-2: The cut-off marks (out of 100) in Tier-I exam would be UR-35, OBC-34, SC/ST-33 & EWS-35 (all Ex-Servicemen would be treated in their own category viz., UR/EWS/OBC/SC/ST).

Note-3: On the basis of their performance & normalization of marks in Tier-I exam, candidates would be shortlisted for Tier-II @ 10 times the number of vacancies, subject to the condition that the candidate should have scored minimum cut-off.

Note-4: On the basis of their combined performance in Tier-I and Tier-II, the candidates would be shortlisted for Tier-III/Interview @ 5 times the number of vacancies subject to the condition that the candidate secures minimum 33% marks (17 out of 50) in Tier-II exam.

7. HOW TO APPLY:

- Applications should be submitted only through ONLINE registration by logging on to the website www.mha.gov.in or www.ncs.gov.in. Applications will NOT be accepted through any other mode.
- The application portal will be operational from 25.11.2023 to 15.12.2023 (till 2359 hours). Registration done, prior to 25.11.2023 and after 15.12.2023, will not be accepted.
- Candidates can apply for the post provided they fulfil the prescribed eligibility conditions.

8. EXAMINATION FEE:

The fee has 02 components i.e., Examination Fee: Rs. 100/- & Recruitment Processing Charges: Rs. 450/- which are required to be paid as under:

Note 1: Ex-servicemen who have already secured employment in civil side under Central Govt in Group 'C' post on regular basis after availing benefits of reservation of Ex-servicemen available to them, are required to pay the examination fee, i.e. Rs. 100/- also along with recruitment processing charges of Rs. 450/-.

Note 2: Banking charges, if applicable, will be borne by the candidate.

9. MODE OF PAYMENT (ONLINE/ OFFLINE MODE):

- The application form is integrated with the payment gateway & the payment process can be completed by following the instructions.
