- v. Design and Analysis report preparation.

2. The tenure of appointment is initially for a period of 1 year or extendable annually subject to satisfactory performance of the candidate assessed annually and requirement of the project or may be co-terminus with completion of the project whichever is earlier.
3. There will be annual increase of 3% on the remunerations subject to continuation based on satisfactory performance and requirement of the project
4. The date of determining the upper age limit, qualifications and experience shall be the closing date prescribed for receipt of completed applications.
5. It is open to the Institute to conduct written test to shortlist the candidates for interview in case the attendance of candidates is more.
6. Age relaxation is permissible to SC, ST & OBC candidates and also to physically handicapped candidate as notified by Government of India from time to time.
