***AGE RELAXATION:** The upper age limit will be relaxable for OBC (NCL) candidates by 3 years. Candidates belonging to PwBD category having minimum 40% disability or more will get 10 years relaxation in upper age limit in addition to the relaxation applicable to the categories mentioned above. Candidates from SC / ST category applying for UR Post will be treated on par with UR criteria.

TERMS OF ENGAGEMENT & REMUNERATION:

Project Engineer-I will be engaged initially for a period of **Three** years which may be extended up to maximum of **ONE** year (**Maximum tenure of 4 years**) based on requirement and individual performance. Candidates will be paid a consolidated remuneration as follows:

Project Engineers –Minimum of 2 years of post-qualification relevant industry experience in Installation, Maintenance & Testing (Telecom / Networking / CCTV / Public address system/ Security System) is required to apply for the post of Project Engineer – I.

NOTE: 1. Academic / Teaching experience will not be considered.

2. One year completed Graduate Apprenticeship training will be considered as experience.

EXPERIENCE & JOB RESPONSIBILITIES:

NOTE: Electrical and Electronics Engineering, Instrumentation Engineering will not be considered relevant.

Job Responsibilities – Candidate is required work in any of the following areas:

1. Candidate will be responsible for project execution, installation, testing, commissioning and support services in association with Project Management Team/OEMs /System Integrators.
2. Development & Engineering - Designing of various parts / Assembly of systems & sub systems, simulation and design validation activity, Preparation of Project documentation.
3. Quality Control Activities – Quality Control & Quality Assurance of Electronics Products including Environmental Testing.
4. Material Management – Managing the procurement and supply chain.
5. Network Switches Maintenance and Hardening, Physical Cabling and Rack Maintenance, RFID Tagging, etc.

Further Candidate may have to travel all over India for official work if need arises, as per Company's requirement.

Mandatory Experience – Minimum 02 years post qualification work experience in one or more areas mentioned above.

NOTE:

MODE OF SELECTION

- Selection will be through a written test followed by interview of only those candidates who qualify the written test in the ratio of 1:5.
- Written Test will consist of objective type questions for 150 marks from Technical domain and General Aptitude.
- All candidates shall secure 35% as qualifying marks and PwBD candidates shall secure 30% as qualifying marks in written test. (Part I and Part II separately).
- Call letters will be sent to the e-mail IDs of eligible candidates for attending the written test. BEL will not be responsible for bouncing of any e-mail sent to the candidate.
- Date, time and center details of the written test will be intimated by e-mail in due course.
- Intimation about the Personal Interview will be given to shortlisted candidates in the Interview Call Letter via e-mail only.
- All outstation candidates shortlisted for Interview will be reimbursed with II class train fare by the shortest route between the correspondence address and place of interview on production of valid train tickets. There will be no reimbursement of fare for attending the written test.
