Reservation policy as enforced at the time of selection would be considered and applicable; provided that in case of non-availability of suitable candidate of reserved category for the posts of Clerks and Stenographers Gr.III, the reserved posts shall be filled up from the suitable candidate(s) of general category.

Selection for the posts of Clerks and Stenographers Gr.III (adhoc basis) shall be made strictly in accordance with amended Rule 7 of the Haryana Subordinate Courts Establishment (Recruitment & General Conditions of Service) Rules, 1997.

1. Essential Qualification:

The candidates for the posts of Clerks and Stenographers Gr.III, should possess a degree of Bachelor of Arts or Science or equivalent thereto from a recognized University. He/she should have passed matriculation examination with Hindi as one of the subject and must have proficiency in operation of Computer.

2. Age Limit (for all posts):

No person shall be recruited to the service, if he/she is less than 18 years or is more than 42 years of age as on 01.01.2024. However, age relaxation for reserved posts shall be applicable as per reservation policies framed by Government of Haryana, from time to time.

3. <u>Last Date:</u>

Last date for receipt of applications shall be **12.02.2024** upto **05:00 P.M.**. Applications received thereafter shall not be entertained under any circumstances. Delay on the part of postal authorities shall not be a ground for entertaining applications received after due date.

4. <u>Mode of selection for the post of Clerks</u>

The candidates shall have to take a written examination in the following subjects:-

Note: No candidate shall be considered for appointment unless he/she obtains 40% marks in aggregate in the written examination and having proficiency in operation of computers.

5. <u>Mode of selection for the post of Stenographers Gr.III</u>

The candidates shall have to pass a test at a speed of 80 W.P.M. in English Shorthand and 20 W.P.M. in Transcription of the same and have proficiency in computers (word processing spread sheets).

6. <u>Date and Place of Examination/Test</u>

The information qua date and place of examination/test shall be uploaded on the official website of District Courts, Faridabad i.e. https://districts.ecourts.gov.in/faridabad in due course. However, no separate letter/information in this regard shall be issued to the candidates. It shall be the responsibility of the candidates to keep themselves updated about the same by regularly visiting the official website of this office after last date of submission of applications.

- 7. **Separate Application for each post** on plain paper mentioning **name of the post applied for** affixing recent passport size photograph mentioning complete particulars i.e. Name. Father's/Husband's Name, Date of Birth, Gender, Caste, Educational Qualification, Experience, Permanent address, present postal address, Nationality, Contact Number along with attested copies of relevant certificates/documents should reach in the office of District and Sessions Judge, District Court Complex, Sector-12 Faridabad, either by registered post or by hand well before the closing date i.e. **12.02.2024 by 05:00 P.M.** Applications received through e-mail shall not be entertained.

Incomplete applications, such as without name of post applied for, date of birth, educational qualification, without photograph, without attested copies of relevant certificates, testimonials and received after due date or before the date of advertisement, shall be rejected out-rightly without any intimation to the candidates.
