11.0 Candidates are required to go through the Post Parameter Table and Vacancy Table of detailed CEN No.03/2024 to ascertain their eligibility before applying through ONLINE mode . Each candidate is allowed to apply to only one RRB and only one common ONLINE application should be submitted by a candidate for any or all of the notified posts, in order of preference. Applications should be submitted only through any of the official RRB websites listed in Para 13.0 below. Once the selection of RRB is made, it shall be final for that RRB. Applying to more than one RRB by a candidate will result in the rejection of all applications.

12.0 Eligibility; Eligibility of the candidates will be provisional based on the details furnished by the candidates in the application. Candidates must satisfy themselves that they are eligible for the post. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his / her application is false/incorrect or the candidate has suppressed any relevant information or the candidate does not satisfy the eligibility criteria for the post(s), his / her candidature will be rejected forthwith.
